Minutes of the meeting

1. All the research supervisors are instructed to refer the college websites of other colleges of MS University for the fee structure regarding research centres and to submit reply in hardy copy on or before 8-1-2025.

2. On the basis of the data of fee structure adhered in the neighbouring colleges as submitted in the meeting, it is suggested/proposed to collect annual fee for scholars in **Arts and Humanities as** Rs.10,500 for **regular** and Rs.13,500 for **part-time** research. Further it is suggested to collect annual fee for research scholars in **Science** as Rs.12,000 for **regular** and Rs.14,000 for **part time**.

3. On the basis of university guidelines and the practices followed in other aided colleges, the Viva/DC fee is revised and same for Arts and Science as Rs.5,000 for DC/ RAC and Rs.10,000 for Viva.

4. It is suggested to collect internal course work examination fee of Rs.500 per course paper and Rs.750 for course mini project for both Arts and Science scholars and the exam duration shall be for three hours. The research centre has to submit the question in a sealed cover to the Chief Controller of Examinations- the Principal and on the day of examination the assigned hall superintendent will conduct and hand over the scripts to the CCE and further documentations will be carried out jointly.

6. Being an unaided college, it is proposed to collect a minimum institutional administrative fee from the research scholars as follows:

- 7. It is decided to mention the vacancy position of research departments in the annual admission advertisement in the newspapers as footnote to invite the prospective researchers.
- 8. It is reminded further to invite external stakeholders related to the Ph.D title during public viva voce examination for the dissemination of the research findings and also to invite the subject expert of the respective BoS.

9. Once in a fortnight, the PT scholars have to visit to the department research centre for the development of academic and professional expertise.

10. All the registers followed in the research centres have to be countersigned by the Principal, who is the head of research centres.

11. The same may be submitted to the Director/Management for review.
